# Family of 3 and more children: family complement

Verified 01 April 2022 - Legal and Administrative Information Directorate (Prime Minister)

The family supplement is a benefit paid under income conditions to persons with at least 3 children over 3 years of age. There is no process to get it. The amount varies depending on the level of income.

## Who is concerned?

### Conditions for children

You must have at least 3 dependent children ([https://www.service-public.fr/particuliers/vosdroits/F16947?](https://www.service-public.fr/particuliers/vosdroits/F16947?lang=en)), aged over 3 years and under 21 years.

### Resource Conditions

Your resources must not exceed an amount determined according to your family situation. That's the categorical net income of 2020 which shall be taken into account for 2022.

#### Status Resource Limits

There are 2 revenues in the couple where each of the 2 receives professional income for an amount at least equal (in 2020) to **€5,594**

If the resources are just over the resource limit, you will receive a differential allowance.

## What approach?

You don't have to do this because the tax services automatically send the information to the Family Allowance Fund (Caf) or the agricultural social mutuality (MSA).

The declaration must be made only if this transmission has not been made.

## How much?

Depending on your income, you receive either the base amount or the increased amount.

Income caps differ depending on whether you are a couple or isolated parent.

## How is the payment made?

The family supplement is paid every month from 3<sup>e</sup> birthday of your youngest child. The payment will stop as soon as you have less than 3 children under the age of 21, or if you have a new child under the age of 3.
