Talent passport: multi-year residence card of a foreigner in France

If you are a foreigner and wish to work in France for more than 3 months, you can benefit from a multi-year residence card *talent passport*. This card is issued to you in several situations, especially if you are highly qualified or want to build a company or invest in France or if you are an artist. It is valid for a maximum of 4 years and renewable.

Qualified employee

You must apply for a card if the proposed length of stay is at least 1 year. If the length of stay is less than 1 year, a [long-stay visa valid for residence permit \(VL-TS \(https://www.service-public.fr/particuliers/vosdroits/F39?lang=en\)\)](#) *talent passport* enough.

Terms

You can get a card *talent passport - qualified employee - exercise of an activity* if you meet the following conditions:

- You have obtained a professional degree or *Specialised Master / Master of Science* (labelled by the conference of the major schools) or at least equivalent to the master
- You have a contract of employment of more than 3 months that provides for gross annual remuneration equal to or greater than €38,475
