# ID of an adult: in case of theft

Verified 08 July 2021 - Directorate of Legal and Administrative Information (Prime Minister), Ministry of the Interior

If the ID card has been stolen, you must file a declaration before you can request a new ID. The documents to be presented depend on the possession of a secure passport.

## In France

If the identity card has been stolen, you must make a declaration to request a new one. The documents to be presented depend on the possession of a secure passport.

## Flight Declaration

### If the flight took place in France

You have to go to a police station or a gendarmerie.

A receipt will be given to you.

### If the flight took place at the foreigner

You should contact the local police authorities and the nearest French consulate.

A receipt will be given to you.

## Where and how to request a new card?

The place of application does not depend on the domicile. You can go to any town hall, provided it is equipped with a registration station.

Your presence is essential for taking prints.

### Warning

The service may require that the file be filed by appointment only.

You can prepare the process by making a pre-application online but it is not an obligation.

You will then have to go to the town hall to finalise the application with the supporting documents.

The counter will collect your data using the pre-application number, verify your supporting documents and take the prints.

## Manufacturing lead time

The identity card is not manufactured on site and therefore cannot be issued immediately. The manufacturing lead time depends on the location and time of application. For example, as summer holidays approach, delays can increase significantly.

### Warning

If the town hall only receives an appointment, the deadline for obtaining this appointment must also be taken into account.

To find out how long the current period is, you can call the interactive voice server.

If you have entered a mobile phone number on the form, you will receive an SMS when the card is available.
