Inclusion Mobility Card (MIC)

Verified 03 June 2021 - Legal and Administrative Information Directorate (Prime Minister)

The Mobility Inclusion Card (CMI) is designed to make it easier for you to move around if you're running out of battery power. There are 3 MICs. IJC **parking** allows parking for free. IJC **priority** allows you to avoid queues or have a seat. IJC **invalidity** concerns you if you have a significant loss of autonomy, it offers the same advantages as the priority IJC with in addition to reductions in transport and tax benefits in particular.

Video: what is the IJC?

Jean-Louis has more and more difficulty walking. Every exit is very tiring. With his son, he goes to the local information point for the elderly where the counsellor tells them about the MICs, the mobility inclusion cards, in number 3: CMI parking, CMI priority and CMI disability.

Parking MCH

What's that about?

This card allows you to use all parking spaces open to the public free of charge and without any time limit. You can use the card if you are the driver of the car or the passenger.

Parking time can be limited by a decision of the town hall. This duration may not be less than 12 hours.

Please note

If you have this old card, it remains valid until December 31, 2026. But you can request the MIC *parking* without waiting for this date.

Who can benefit?

You can take advantage of it if you meet one of the following conditions:

You have a disability that significantly and sustainably reduces your mobility or you must be accompanied by a person on all your trips

Request statement

You may be called by a multidisciplinary team of the MDPH (e.g.: doctors, occupational therapists, psychologists, social workers) to assess your mobility.

You are not affected by this assessment if you perceive the Apa.

Your card request is answered within 4 months. If you do not receive a response at the end of a 4-month period, your request is considered to be rejected.

Once the application is accepted, it takes approximately 10 days to receive the card.

Usage

You must secure the card against the windshield of your vehicle.

Assignment Duration

The card is assigned definitively if you are in the Apa and are in group 1 or 2 of the Aggir grid.

Apart from this, the IJC is granted for a period of up to 1 to 20 years.

What should I do if I lose, steal or destroy the card?

You owned the IJC
