curfew and containment: what are the rules?

Verified 29 juin 2021 - Legal and Administrative Information Directorate (Prime Minister)

During the coronavirus-related health crisis (Covid-19), travel outside the home is limited depending on the severity of the situation. In view of the improved health situation, the containment was removed and the curfew in force in metropolitan France was lifted on Sunday, June 20, 2021. In addition, there are still travel restrictions and the situation varies from one territory to another.

Of **restrictions** (<https://www.service-public.fr/particuliers/vosdroits/F35613?lang=en>) shall also apply to journeys between mainland France, overseas and foreigners.

What are the rules in your area?

Travel or voucher

To get out during the curfew, you must have a document with you that justifies you moving for one of the permitted reasons.

Amount of fine

Failure to comply with the travel ban constitutes offence.

Detail of sanctions

First offence

Failure to comply with the travel ban constitutes contravention 4th class fined €135.

If you do not pay or contest within the time limit specified on the notice of violation, the fine is increased and the amount of the fine is increased to €375.

New offence within 15 days

A 2nd prohibited trip within 15 days of a first offence is a 5th class fined €200.

If you do not pay or contest within the time limit indicated on the notice of violation, the fine is increased and the amount is increased to €450.

More than 3 offences in the month

Making more than 3 prohibited trips in a one-month period constitutes a crime, punishable by 6 months in prison and a fine of €3,750. Two additional penalties may be added to such convictions: the work of general interest (<https://www.service-public.fr/particuliers/vosdroits/F1407?lang=en>) and the suspension of the driving licence for a maximum period of 3 years.

Who can impose sanctions on you?

The fine for contravention may be imposed by the following officers:

- National and Municipal Police Officers
- Gendarmes
- Agents of the City of Paris
- Country Guards

After 3 tickets within 1 month, a new forbidden move constitutes an offence, which will be tried by the correctional court.

How do I challenge a penalty?

If you feel that the lump sum penalty is not warranted, you can challenge the contravention.

You must meet the following deadlines to contest the fine:

- Flat fine: 45 days from the date the notice of contravention was sent
- Increased flat fine: 30 days from the date the notice of increased flat-rate fine is sent.

You will have to pay an amount equivalent to the amount of the fine, called logging.

Online

The protest can be held directly online on the website of the National Automated Crime Processing Agency (ANTAI).

Flat fine notice: online protest

Use to challenge a flat-rate or increased flat-rate fine online or to designate another person.

Attention: you can no longer contest whether you paid the fine. Indeed, paying the fine means that you acknowledge having committed an offence.

You can attach a scanned copy (scanned in PDF, JPG or ZIP format) of the Notice of Violation or the Exemption Request Form. However, this part is not required to do the gait.

By mail

You must complete the form attached to the notice you received:

- Notice of Violation Request Form
- Claim form for increased lump sum fine.

Follow the instructions on the form to complete it and know what documents to attach (notice received, letter on free paper indicating the reasons for your protest, etc.).

Documents must be sent by letter RAR to the Public Prosecution Officer (OMP). His address is on the notice.

Officer of the public prosecution can take one of the following 2 decisions:

- If your challenge is rejected, then your deposit is equated to the payment of the fine.
- If your dispute is admissible, your file is then forwarded to the officer of the public prosecution who can file or prosecute you in the police court.

You are notified by mail of the decision.

If you are being sued before the police court (<https://www.service-public.fr/particuliers/vosdroits/F1457?lang=en>), there are 2 possibilities:

- You are released and refunded from the deposit
- You're fined. The amount shall be at least equal to the amount of the flat-rate fine or the increased flat-rate fine plus 10 %. Depending on the offence committed, the judge may also decide on an additional penalty (e.g. driving licence suspension)

 **Please note :** if you are convicted by the police court, or by the correctional court, you must appeal (<https://www.service-public.fr/particuliers/vosdroits/F1384?lang=en>) to challenge the sanction.
