## Calculator for 2021: 2020 Income Tax (Simulator)

Ministry of Finance

This simulator allows you to determine the amount of your income tax.

- You can use **simplified model** if you report wages, pensions or pensions, property income, earnings from disposals of securities, social rights and similar securities. Also if you deduct current expenses (alimony, child care expenses, donations to works ...).
- You can use **full model** if you report in addition to income from commercial, liberal, agricultural activities, income of partners and managers, investments in DOM-COM, global deficits...
