## Online application for a valid driving licence (Online Service)

National Secured Securities Agency

Accessible with FranceConnect or **identifiers CHILDREN** (). If you don't have one, you are asked to create an account to have a personal space on the ANTS website.

It allows you to apply for a renewal of title for **end of licence**.

You need:

- **Digital Signature** [↗](https://permisdeconduire.ants.gouv.fr/services/geolocaliser-les-photographes-habilites) (<https://permisdeconduire.ants.gouv.fr/services/geolocaliser-les-photographes-habilites>) . If you don't have access to a digital signature and photo service, you can complete and mail a photo signature (FPS) form during the remote procedure.
